#### Minutes of the NHF board meeting on SKYPE, 13 February 2018

# 1.-3. Opening, organization and approval of the meeting agenda

Linus Zhang opened the meeting at 13.15. Linus Zhang was appointed as the Chair and Heidi Lee as the Secretary. The minutes will be scrutinized jointly. # 4. Minutes from the previous board meeting 30.8.2017

# 5. Meeting costs for this meeting

#### 6. Finances

The result and balance reports for years 2016 and 2017 were discussed and approved.

The membership fees for 2017 from Norway were transferred to the Treasurer in January 2018. The sum NOK 20 200 will however be booked in 2017 as an 'open trade receivable' To sum up:

The financial conditions of NHF are still good but the yearly deficits decrease the equity capital.

Martin presented the budget for 2018 and 2019–2020. The budget is going to be updated prior to the General Assembly. The challenge is that the membership fees and other income cannot cover the costs. Another approach is needed for financing the activities.

In the board meeting 24.3.2017, Linus and Dirk were pointed out as a working group that will work with membership recruitment. They will also look into how to finance the activities since collecting the membership fees has been a challenge for several years. The working group will present its recommendations prior to the General Assembly.

#### 8. Nordic Hydrological Conference (NHC)

NHC 2018 in Norway – final budget and an update from the organising committee: The final budget was presented and approved. Several institutes will support the conference, altogether with NOK 450 000. The registration is open. The deadline for abstract is 1 March 2018. The website <a href="https://www.nhc2018.org">www.nhc2018.org</a> will be updated continuously.

NHC 2020

Estonia will organise the NHC in 2020. The NHC 2020 will be announced during the NHC 2018 in Bergen. Elve Lode presented the preliminary plans and ideas.

#### 9. Marketing: publishing, web pages and Hydrology Research

**Repetition** from the previous meetings:

The special issue of HR from the NHC 2016 Will be published in April 2018, altogether 15 papers.

Greetings from the meeting with IWA publishing held in December 2016

The journal needs more publicity among the members. The instructions how to subscribe and how to access the journal are going to be improved. Chong-Yu follows up.

Campaigns to increase awareness interest in the association (HR survey, etc.) The British Hydrology Society (BHS) has carried out a membership survey regarding the journal Hydrology Research in 2015 to find the members' opinion about the journal. A similar, online survey will be carried out among the NHF-members during the NHC 2018. The results will be distributed after the conference. Chong-Yu and Dirk have the responsibility to organize the survey. The board members are to send questions to the survey.
